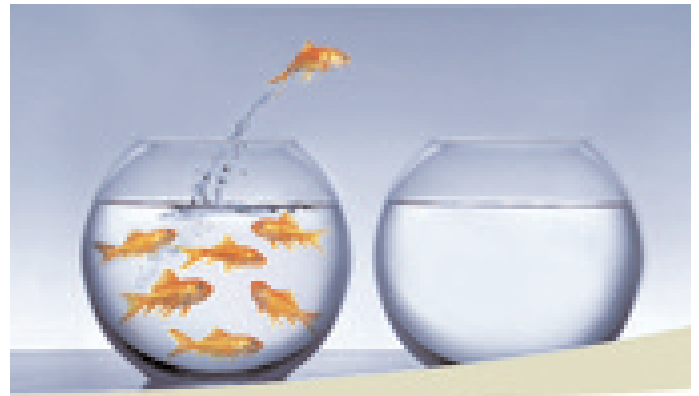

Learners are then required to demonstrate their ability to plan, deliver and review coaching supervision with individual coaches and groups.

For the [Certificate](#), this comprises at least [30 hours](#) of coaching supervision.

For the [Diploma](#), this is extended to [100 hours](#) of coaching supervision, and there is an added focus on comparing and contrasting individual supervision relationships across different levels of complexity within an organisation.

The 100 hours of coaching supervision for the Diploma qualification unit may include 30 hours that have been accredited as part of the Certificate qualification unit
